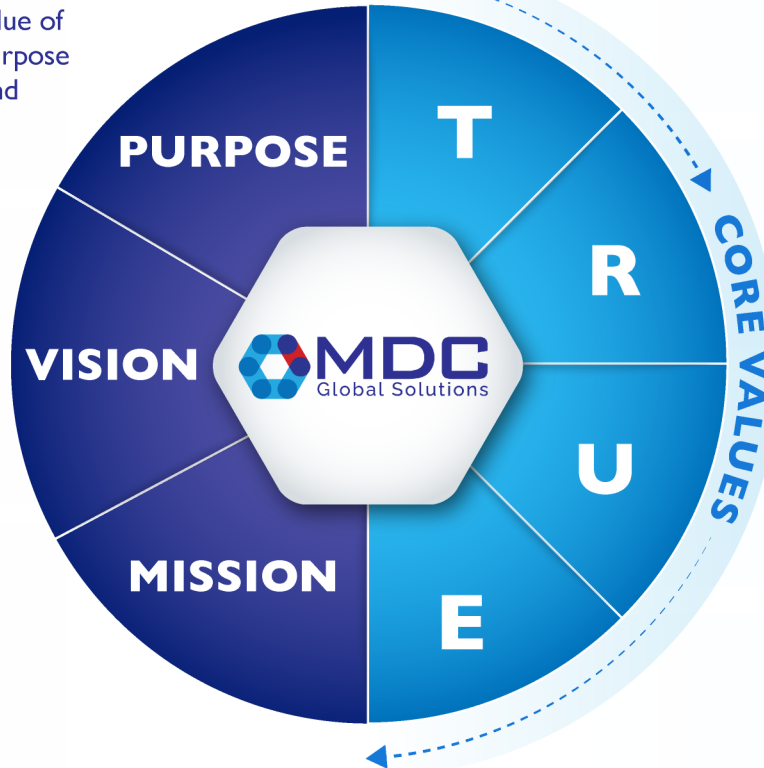

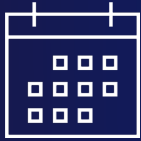

Optimizing Financial Management with Expert GFEBS Support



MDC Global Solutions LLC, provides specialized enterprise service desk support to enhance the use of the General Fund Enterprise Business System (GFEBS). Over the last seven years, MDC has offered a range of tailored services to more than **1,200** end users which include on-site support, issue resolution, and user training to address challenges during post transition from legacy systems to GFEBS.

The Defense Health Agency (DHA) Financial Operations Division (FOD) leverages ServiceNow for essential IT service management and operational support. This platform enhances efficiency by streamlining workflows and providing real-time support, allowing DHA FOD personnel to promptly address technical and operational challenges, ultimately improving healthcare support services.



DHA FOD faced challenges expanding IT services due to inefficient manual processes for managing service requests and incidents. To enhance operations, improve service delivery, and meet federal regulations, a scalable solution was needed.



We successfully identified and provided deployment support for ServiceNow, enabling effective management of all financial business functions and payroll for the entire Military Health System workforce, which covers over **140,000** civilian employees.
